



PUTTING CHILDREN FIRST

A manifesto to keep every child in your community safe, loved and well.

Children 1st, Scotland's national children's charity, wants to ensure that governments at every level do everything in their power to protect children and childhood.

While systems around children and families struggle to protect them from poverty and harm, the world they are living in is changing and new risks are emerging. By taking the following six actions governments can support children and young people to grow up safe, happy and together with their families.

- ▼ Tackle child poverty.
- Protect children from online harm.
- **∀** Invest in early help for families.
- ♥ Support children's mental health.
- Incorporate the United Nations Convention on the Rights of the Child (UNCRC) into domestic law at a UK level.
- Roll out a consistent, high-quality Bairns Hoose.

Keeping every Child safe and loved in their own family

Tackle child poverty	
Child poverty is being normalised, with almost 250,000 of Scotland's children officially recognised as living in poverty. Children 1st financial wellbeing teams reported a 92% increase in families seeking help last year. Rising costs hit families with children particularly hard, and too often there are barriers between families and the support they are already entitled to. By supporting families to manage their budgets and access the support they are entitled to, our team recorded over £1.9 million in financial gain for families in 2023-24.	
Removing the two-child cap and introducing a national programme of financial wellbeing support would stop the welfare system penalising children and families.	
Protect children from online harm	
Online harm is one of the greatest threats to children's wellbeing and their opportunity to enjoy a childhood safe and free from mental or physical harm, including sexual harm. Children describe violent and pornographic content as "unavoidable" online from primary school onwards, but too often, regulation struggles to keep up.	
Children, young people and families Children 1st work with are aware of, engaged with and can help to address these challenges, even when they seem insurmountable.	
Governments across the UK and world-wide must work together to protect children from online harm as a top priority and to prevent risks as they develop, through research, support to children and young people and ongoing regulation.	
Invest in early help for families	
Families are reaching crisis point before they can get help, leading to an over- reliance on costly child protection interventions which cause more harm than

___ Incorporate the UNCRC into domestic law at a UK level. ___

The UNCRC (Incorporation) (Scotland) Act 2024 is a bold commitment to children, young people and their families. This marks an incredibly important moment for children's rights in Scotland, but the lack of UK wide incorporation means there are still gaps.

UK wide incorporation of the UNCRC would simplify and strengthen protections for children's rights so that all children, in all circumstances, have their rights fully protected and respected.

Children who are victims and witnesses are traumatised by their experiences in the criminal justice system, as they are asked to repeat their stories over and over, while facing delays and adjournments. This leads to poor quality evidence that results in prosecutions failing and children and families feeling let down and unsafe. In August 2023 Children 1st opened Scotland's first Bairns Hoose, based on the European Barnahus model, which gives children who experience abuse and violence all the protection, care, justice and recovery support they need under one roof, without causing further trauma.

Rolling out Bairns Hoose would ensure that children can share their stories and pre-record their evidence, so they are not asked to go to court unless absolutely and unavoidably necessary.
