What is payroll giving?

Payroll Giving is an easy way to make a regular donation to Children First directly from your salary before tax.

Payroll Giving not only gives charities regular and reliable income, but also provides a tax-break on your donations depending on your tax rate.

Example of how Payroll Giving and tax relief works

Your donation	Tax relief (20% Scottish basic rate)	Actual cost to you	Children First receives
£10	£2	£8	£10
£25	£5	£20	£25

Your donation	Tax relief (42% Scottish higher rate)	Actual cost to you	Children First receives
£10	£4.20	£5.80	£10
£25	£10.50	£14.50	£25

How do I sign up?

Contact your payroll team. Your employer must be set up with a Payroll Giving agency to process donations. (We currently work with GoodPAYE to help employers get set-up with Payroll Giving.)

When you have confirmed this, simply let them know how much and how often you would like to donate to Children First. You can also sign up through our online form at **www.childrenfirst.org.uk/payrollgiving**.

Your donation will then start to come out of your gross salary, tax free on a regular basis, it is that simple!
